On behalf of the Board of Directors of the Commission on Accreditation of Medical Physics Educational Programs (CAMPEP), I am pleased to inform you that the Texas Oncology Medical Physics Residency Program has been granted provisional accreditation through December 31, 2014. Once you notify us that a resident has graduated from your program, accreditation will be extended to December 31, 2016. Accreditation can then be extended to December 31, 2018, with the stipulation that acceptable annual reports are provided. Although the application was originally for multiple sites organized as pods, the consensus of the site visit team was that these pods appear to interact mainly with each other and minimally with centers outside of the pod. Consequently there is not a strategy to ensure uniform quality of training at the multiple sites, whereas the training at the Dallas site meets CAMPEP standards. Therefore, the program accreditation is limited to the single Dallas site for two years.

Please accept our congratulations on the accreditation of your program. A copy of the Program Review Document is attached, which identifies suggestions for improvement on your program. You are expected to provide annual progress reports on these suggestions and also to provide information regarding any substantive changes in the program.
